(This ordinance will establish the final budget for the city's 2018-2019 fiscal year (subject to future amendment), including setting the property tax rate and levying the related property tax. It also will authorize and direct the filing of the related Form PT-800 with the Utah State Tax Commission to the extent that the ordinance sets a property tax rate above the current certified rate).
