



Superhero Bike Ride Registration and Release

IN CONSIDERATION OF the city of Cottonwood Heights (“*City*”) allowing me and/or my minor child(ren) (collectively, the “*Participant*”) to participate in Superhero Bike Ride sponsored by City (the “*Ride*”), I make the following representations and agreements for myself and the Participant. This document (this “*Release*”) binds each Participant and its heirs, insurers, personal representatives, guardians, administrators and assigns.

1. I acknowledge that participating in the Ride and associated activities involves some degree of risk, and I fully realize, and I have explained to any other Participant, the dangers of participating in the Ride. **I voluntarily assume, for myself and the Participant, all risks associated with such participation**, including, without limitation, the dangers of collision with other participants, pedestrians, vehicles or fixed or moving objects; the dangers arising from surface hazards (such as potholes), equipment failure, weather conditions, inadequate safety equipment, use of equipment or materials provided by City and others, inadequate adult supervision, and the negligence of the Participant or others; and the possibility of serious physical and/or mental trauma, injury or death associated with the Ride or associated activities.

2. Before the Ride, I will inspect the course, facilities and the equipment to be used in the Ride and, if I believe that anything is unsafe, I will immediately so advise City’s representatives at the Ride and will refuse to allow the Participant to participate in the Ride until such unsafe conditions are corrected.

3. I will accompany and supervise any minor Participant in the Ride. I agree that City has no responsibility to supervise the Participant in the Ride.

4. The Participant does not have any physical or mental condition which would endanger the Participant or others through participation in the Ride. I agree that provision of medical services and other aid rendered to the Participant during or after the Ride is not an admission of liability.

5. I understand that the Ride and its participants may be photographed, filmed or recorded. I agree that any resulting likeness of the Participant may be used for any legitimate purpose by City and Ride sponsors.

6. **I waive, release and forever discharge** City and any Ride sponsors, and any of their respective officers, employees, agents, licensees, volunteers, or other related parties, the owners or occupants of any premises used in the Ride, or any other participants in the Ride (collectively, the “*Released Parties*”), from any and all claims, demands, losses, liabilities, damages, costs and fees (including attorneys fees) on account of any personal illness or injury (including death) or property damage arising from or in any way relating to the Participant’s participation in the Ride, whether caused by negligence or otherwise. I acknowledge and agree that an effect of this Release is to free the Released Parties from any liability for injuries or death sustained by the Participant resulting from the Participant’s participation in the Ride. I understand that if the Participant is injured in the Ride, this Release will be used against me, the Participant and anyone else claiming damage.
